Men's stories – How they impact the whole family

1. Hi Mens Aid,

I have only just found your website after an article I read in the paper. I have suffered for years at the hand's of my wife. We have been married over seven years and have two children ages 5 and 3. The verbal abuse started before we were married and the physical a few months into it. Initially I didn't realise what was happening. When my wife started to push me around, I started to push her back. But as her abuse became serious I quickly got the measure of the situation and simply stood to take it. I realised that retaliation "was not the solution".

The verbal abuse is still simmering in the mode of "don't start me", which I know will once again progress into physical form. I never know one day to the next what her mood is going to be, or how it may develop. I am truly walking on egg shells never knowing when one is going to break. I hold the same aspirational values as women i.e. to have mutual respect in a relationship and not have to endure violence.

Chief Executive's Report

Dear reader,

Thank you for picking up our annual report to read about our support service. I joined the team of Men's Aid in January 2020 and it was an extraordinary year to say the least. Given the low levels of reporting we wanted to make it as easy as possible for the student or men experiencing abuse to find us and seek support and very quickly we rebranded and renamed to Men's Aid.

As a national service who has been supporting men experiencing domestic violence for over 20 years, our team have a unique understanding of what it is like for men subjected to violence, coercive control, parental alienation even child abduction.

Our team are the experts on the ground and we know the challenges faced by men to come forward and seek support. We understand the gender bias, the fear, the shame, the stigma men feel. We listened to thousands of hours of disclosures including fear, isolation, and shame, stories of horrific violence, suicide ideation, and homelessness.

I have been encouraged to hear of Minister McEntee's commitment to this social issue and welcome the ambitious efforts in creating the next 3rd National Strategy to combat Domestic, Sexual and GBV. By including our data from 2020 and our frontline experience we will provide opportunities, as communities to reach out to victims and to work towards safer communities and a safer country.

We are challenged every day by gender bias and inequality however, as I write this letter I am so proud of what our tiny team accomplished during 2020 as we know we changed and saved men's lives. We are hopeful our work will translate into national policy in order to reduce suicide, reduce homelessness and support the men on their journey to safety.

Equality and human rights are at the centre of all our work, always victim centric and we prioritise child safety with every call we take and every face to face meeting. Ireland has a lot of work to do to keep people and families safe and we are committed to work in a collaborative manner with fellow stakeholders to achieve zero tolerance for everyone.

Training

We are the experts in this field supporting men experiencing abuse, both from female and male partners. With over 20 years' experience, backed up with evidence based research from both Ireland the UK and across the globe. Our training is delivered by QQI level 6 accredited trainer and is in line with QQI standards. Our training can be delivered online and in person (in-line with covid-19 guidelines)

Impact

- We supported 5124 helpline calls
- Average call time increased to 40 + minutes
- Delivered 381 Counselling appointments
- Supported 182 men in the Dublin Family Courts.


Community Response Hubs & **Court Support Locations**

Judgements and key sources of estimation uncertainty

Estimates and judgements made in the process of preparing the entity financial statements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Useful economic lives of tangible fixed assets

They are amended when necessary to reflect current estimates, based on technological advancement, future investments, economic utilisation and the physical condition of the assets.
